RIGHT TO KNOW RECORDS REQUEST

PUBLIC INFORMATION AND RIGHT TO KNOW

The Otto-Eldred School District will provide public records in accordance with School Board Policy 801 and the Pennsylvania Right-to-Know Law.

Right to Know requests will only be fulfilled if submitted by a person who is a legal resident of the United States. Anonymous requests will not be fulfilled. We reserve the right to request proof of a requester's status in the form of submission of any or all of the following: a physical address, proof of legal status in the United States such as a social security number, copy of passport, driver's license or immigration documents.

DEFINITION OF PUBLIC RECORD

A record including financial record, of a local agency that:

- Is not exempt under Section 708 of Right-to-Know Law
- Is not exempt from being disclosed under any other Federal or State Law or regulation or judicial order or decree
- A record that is not protected by a privilege

OPEN RECORD OFFICER

The Business Manager shall be the Open Records Officer of the Otto-Eldred School District.

Open record requests can be submitted by completing a Right-to-Know Request Form (state Office of Open Records Form) via below methods:

APPEALS

In the event that a requestor is denied release of record by the Open Records Officer, he/she may appeal within 15 business days to the state's Open Records Appeals Officer pursuant to section 1101 of the Right-to-Know Law.
